
- (5) **SPECIAL CONTINGENCIES** : Installing New Franklin Fueling fiberglass tank sumps with new FE Petro Submersibles, ball valves & partial Ameron single wall fiberglass piping to pipe back into the sumps ( less than 20' per sump ). Installing new EBW 705 series 5 gallon spill & vapor containment manholes with OPW 71SO-410C overfill drop tubes. Reusing Veeder Root tank & PLLD line leak detection.
