We will be installing only 1 new FE Petro 2 HP submerge pumping unit and repipe inside the sump only from teh fiberglass product line male adapter and install new 2" SS flex connector, ball valve and related steel fittings

No other work outside of the sump will be done

Location currently has a Veeder Root PLLD line leak detector which we will install on new submerge pumping unit.
