The Owner wants to replace the final 2 dispenser sumps under 5/6 and 7/8 do to recent flex connector issues under other dispensers.

This will complete a the isntallation of all (4) sump replacements under all gasoline dispensers at this location.

We will have third party pressure test on lines after lines are OSFM inspected and purged.
