A required job schedule for cathodic protection upgrade of underground storage tank(s) and piping must be submitted to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.
