(5) <u>SPECIAL CONTINGENCIES</u>:

Not installing DWFRP pipe, only SWFRP pipe. Need to remove the DWFRP from list and also remove the sump sensor as this will not be installed either. Saw cut and remove concrete from around tank to gain access to tank top. Replace existing STP and STP Sump, cut back and repipe to existing product and vent piping, install new extractor vavle and fill and probe risers. Install new drop tube and interstital senors. Install new spill containers.
