We will removing the existing Multi Port fills on the both RUL tanks and Diesel tanks.

We will remove teh Veeder Root Sump sensor in these sumps only and program out of sytem.

We will install new OPW1C-2100C-PEVR grade level overspills with new swivel fill adapters. We will also replace the 4" tank risers. We will backfill old multiport sump area with pea stone.

Note: we will inspect and test existing ball floats on Stage 1 vapor and if they do not pass inspection we will then install new OPW
