This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) **SPECIAL CONTINGENCIES**: Removal of 2-4,000 gallon heating oil USTs from the parking lot area.
