(5) **SPECIAL CONTINGENCIES** : Tank relining lining inspection and entry permit work in reference to manways/manholes must abide by section 175.500. Saw cut and remove concrete from about tank. Create entry point into the tank to allow for inspection of lining. Install new manway once inspection and any repairs are complete. Replace concrete and install manhole. **NOTE: The manway installation is the only work being performed by this Neumayer Equipment. A different contractor is going to permit the Lining Inspection as Neumayer does not have the proper license.**
