Permit for REMOVAL of Underground Storage Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(5) **SPECIAL CONTINGENCIES** : Remove all piping and islands going to the front (gasoline) islands including the diesel piping. Piping going to the rear diesel islands is to remain.
