#### (5) SPECIAL CONTINGENCIES:

- Removing existing (9) islands. Only the diesel island will be replaced to its formaer location. The (8) gasoline islands will be removed and replaced with (4) islands. Island size 3' x 5'.
- Removing exisiting fuel piping. Vent lines to remain.
- Reuse existing Veeder Root TLS 350.
- Reuse Existing Submersible pumps and mechanical line leak detectors.

- Reuse existing Tanks.
- Existing canopy to remain.
- Installing (4) new tank top piping sumps.
- Installing (5) new dispenser sumps.
- Installing new Veeder Root sump and dispenser sensors.
- Installing new Ameron Dualoy LCX piping from tank top sumps to island dispenser sumps.
- Installing new OPW 5 gallon overspill manholes.
- Concrete to be repaired when work is complete.
