(5) <u>SPECIAL CONTINGENCIES</u>:

Contractor is running a new manifold line between tanks 10 and 12 as shown in the site drawing. Tank 10 submersible will be the primary and tank 12 will be the slave tank with check valve. Both sumps have existing sensors.

Product piping from tank 12 submersible to islands will be capped at the submersible and under dispensers. An abandonment permit must be obtained in order to do this.
