Such abandonment must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175, and 176. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(3) **ABANDONMENT IN PLACE OF TANKS:**

- (a) *Number and size tanks being abandoned: (TK # 1) - 6,000*
- (b) *Product stored in each tank: (TK # 1) - Gasoline*
- (c) *Location of tanks being abandoned: Tank is no longer in use, power line is directly over the tank as shown in drawing, making removal impossible.*

If contamination is revealed, this abandonment can continue only when the contaminated site section (2) of the certification on site condition has been submitted to our Office.
