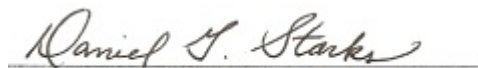
My crew could not get the OPW spill container on due to height of the surrounding concrete. An EBW 705-470-01CI, will be installed to meet the height restrictions.
