- Removing existing piping and pulling a new ASP SC150 double walled pipe through existing duct pipe
- Installing new shear valves under each dispenser
- Installing new ball valve at submersible pump
- Installing new FE Petro 3/4HP submersible pump

NOTE: If there are no sumps at the dispensers or submersibles ones must be installed per 175.410
