
(5) **SPECIAL CONTINGENCIES** : Remove Beaudreau sensors and install Veeder Root wireless discriminating sensor 857080-111. NOTE: Sensors must have the capability to shut down the stp supplying that line upon the detection of a leak, per section 175.640 a) 2) Replace shear valve under dispenser 11/12 RUL. NOTE: If there is not an existing dispenser sump one must be installed per 175.410 d) Install intercom to all dispensers.
