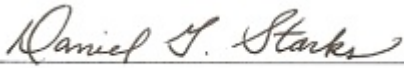
(5) **SPECIAL CONTINGENCIES** : Removing and replacing flex connectors in all (4) tanks along with installing necessary secondary test boots.
