THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.

This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) SPECIAL CONTINGENCIES: The site is being redeveloped and the old facility was demolished. The tanks are now accessable and need to be removed to allow for the new building construction.
