After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) SPECIAL CONTINGENCIES: During site clearing excavation for a new development 4 underground storage tanks were uncovered. These were not reflected on any drawings and there is no known usage on this facility. All tanks and associated old vent piping will be removed. The orphan tank letter is attached.
