(5) **SPECIAL CONTINGENCIES** : Shear valve under dispenser #1/2 connected to Tank# 3 Premium Gas does not pass functionality testing and needs replacing. A third party test will be performed prior to returning to service. **NOTE: If there is no containment sump where piping is being broken then a sump must be installed per 175.410 d)**
