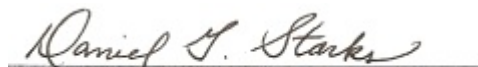

Reworking existing piping and electrical conduits to accommodate the new sump. Performing a nitrogen test on the piping and a hydrostatic test on the sump and penetrations after the replacement is complete. All set backs are existing.
