- (5) <u>SPECIAL CONTINGENCIES</u>: We will saw cut and break concrete around the Plus tank riser. We will remove and dispose of broken concrete. Remove backfill around riser to top of the tank. Remove and replace riser pipe. Install new riser pipe, new spill containment bucket, and a new overfill protection drop tube. Replace backfill around riser, pour and finish concrete.
