This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

- (5) SPECIAL CONTINGENCIES** : Removing 3 existing steel underground storage tanks. Removing all existing product and vent piping. Removing fuel islands.
