**(5) SPECIAL CONTINGENCIES :**

We will remove existing APT poly sumps on all (4) tanks and install new Bravo single wall sumps. We will have Containment Solutions on site to install new 42" tank collars on tanks prior to installing new Bravo sumps

We will be using Bravo FRP entry fittings for product piping and electrical entry.

We will re install existing APT P-175 poly tec piping through new entry boots

We will be installing (4) new FE Petro variable speed 2 hp submerge pumps with VST controllers.

We will hydrostatic sumps and schedule OSFM inspection

We will reuse existing Veeder Root PLLD's and internal sump sensors
