This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

- (5) SPECIAL CONTINGENCIES** : Excavate and remove (2) 2,000-gallon underground storage tanks.
