
- (5) **SPECIAL CONTINGENCIES** : Due to a sump to tank adapter failure the Regular tank is taking on groundwater. The existing double walled fiberglass piping will be cut back so teh sump can be removed to access the failed adapter. The exisitng sump will be reset on the new adapter and the double walled piping will be run back into the sump with new galvanized steel fittings, flex connector and ball valve installed within the new sump.
