- Ⓡ Remove and replace total of twelve (12) 2" secondary piping test boots with ICON repair test boots
- Ⓡ Remove and replace total of three (3) 3" Environ product penetrations with ICON repair penetrations
- Ⓡ Reinstall and pump test dispensers
- Ⓡ Prepare and hydrostatically test three (3) UDC's at 4" above highest penetration
- Ⓡ Properly dispose of test water
