**(5) SPECIAL CONTINGENCIES** : Repairing Cut anodes wires to all tanks. Contractor cut Anodes Wires during construction.

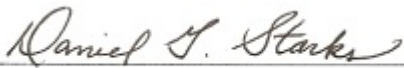
