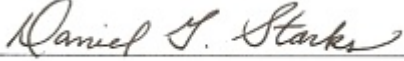
- (5) **SPECIAL CONTINGENCIES** : Replace spill containers, drop tubes and fill riser on all tanks. Remove ball floats in all tanks
