The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

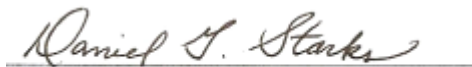
(3) UPGRADE OR REPAIR OF FLEX CONNECTORS:

- (a) *Number and size of tanks being upgraded or repaired:* (TK # 1, 2) - 10,000 gallons, (TK # 3, 4) - 8,000 gallons
