(5) SPECIAL CONTINGENCIES :

Do to inspection the existing Ball Floats on each tank are sized and cannot be tested.

We will be installing on all tanks new OPW 71SO-400C overfill drop tubes.

We will also be replacing the existing OPW 5 gallon overfills at same time. I will issue a Like for Like replacement for this.

The 4" tank risers on the Stage 1 vapor need to be replaced as well.

The 4" fill risers might need to be replaced if existing straight drop tubes cannot be removed

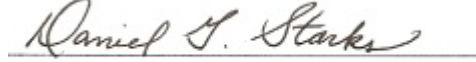
