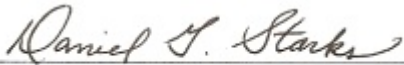
- (5) **SPECIAL CONTINGENCIES** : Installing new flex connectors and shear valves on the diesel dispensers. (existing dispenser sumps). Installing spill buckets and overfill drop tubes on the UL and K-1 tanks. The steel riser will be replaced on the k-1 tank. **NOTES: This permit replaces permit 00537-2019UPG, the contractor accidentally submitted for a new permit instead of an amendment and instructed me to issue this one and he would cancel previous permit. Our records do not indicate any existing ball floats.**
