(5) <u>SPECIAL CONTINGENCIES</u>:

We did not have to install new 4" risers in the UL tank. There was an existing riser we used for the vapor adapter and we did not need one on the spill bucket. We only installed one riser on the K-1 tank. NOTE: This permit replaces permit 00537-2019UPG, the contractor accidentally submitted for a new permit instead of an amendment request and instructed me to issue this one and he would cancel the previous permit. Our records do not indicate any existing ball float valves.
