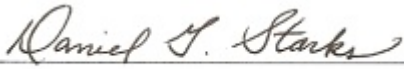
(5) **SPECIAL CONTINGENCIES** : Regular tank is taking on water. Replacing all the 4 inch steel risers on this tank.
