- (5) <u>SPECIAL CONTINGENCIES</u>: Add a siphon line between the two diesel tanks. **NOTE**: Siphon Bars. Siphon bars that are used to transfer petroleum and hazardous substances between tanks by means of gravity or negative atmospheric pressure shall be permitted subject to the following requirements:
 - 1) The height of the tops of all tanks connected by the siphon bars shall be within 6 inches of each other;
 - 2) Piping shall meet the requirements of Section 175.420; and
 - 3) Release detection methods for tanks and piping shall be of a type approved?
