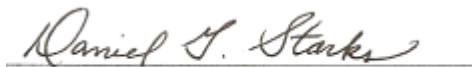
- (a) Number and size of tanks being upgraded or repaired:* (TK # 4) - 10,000 gallons, (TK # 5) - 6,000 gallons
- (b) Type of flex connector(s):* (TK # 4, 5) - Existing steel flex connectors
- (c) Product stored in each tank:* (TK # 4, 5) - Gasoline
- (d) Corrosion Protection being installed with flex connector(s):* (TK # 4, 5) - (Installing) Sacrificial anodes cathodic protection in submersible sumps only
