Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, by telephone at the Springfield office between 8:30 a.m. and 12:00 p.m., at which time a mutually agreed upon date and time for the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 170.640 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

- (5) **SPECIAL CONTINGENCIES:** This permit was never processed. It was actually processed as an amendment to permit #01135-2006REM; however, the fee was never applied to the permit application that it was received as. Due to auditing findings, this permit application was discovered in the facility file. It has been processed as a permit to correct the \$200.00 fee that was on the unallocated cash report.
