Permission to upgrade or repair flex connector(s) is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Part 170. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

- (c) *Product stored in each tank:* (TK # 6, 7, 8) - Gasoline
- (d) *Corrosion Protection being installed with flex connector(s):* (TK # 6, 7, 8) - (Installing) Sacrificial anodes cathodic protection at submersible sumps only.

(4) The owner must notify this Office when completion of flex connector upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for flex connector to the OSFM prior to the work being performed.
