Permit for UPGRADE or REPAIR of FLEX CONNECTOR for existing Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to upgrade or repair flex connector(s) is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Part 170. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.

- (d) Corrosion Protection being installed with flex connector(s): (TK # 1, 2, 3) (Installing) Sacrificial anodes cathodic protection at all submersible sumps only.

- (5) <u>SPECIAL CONTINGENCIES</u>: This permit is not valid until we receive a notification form to register these tanks. This application was originally sent in with the wrong facility number / address. A conversation with Inspector Weedman 03/19/08 at 1:30 verified the correct address of this site, and verified that he was told a notification form is being sent in to register these tanks. These tanks were installed in 2002; however, they were never registered (see permit and inspector logs for #01311-2002INS).
