- (5) <u>SPECIAL CONTINGENCIES</u>: Regular dispenser piping and regular sub unit piping failed Cathodic protection testing and needs anodes replaced. Diesel dispenser piping and sub unit piping passed at a low level and also will be upgraded under this permit. Spike anodes are being installed at the submersible pumps as well as under the dispensers. Contractor says there are no existing sumps at this site.
