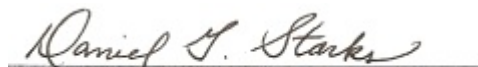

- (5) SPECIAL CONTINGENCIES** : Remove 4 under dispenser containment sumps and replace with new Bravo fiberglass Model #B1670-S30. Install new Veeder-Root sump sensors in all 4 sumps. Install new Gasboy Atlas Master/Satellite configured dispensers. Remove and replace the Diesel submersible motor.
