(5) **SPECIAL CONTINGENCIES** : Owner wants to install supplemental annodes on the existing Sti-P3 tanks while the tanks are uncovered for work on going by another company on an upgrade permit. we will install five 5 lb anodes to each existing tank. We will spread the anodes out around the tanks as allowed by the length of wire on the anodes. The existing CP spike anodes on the piping at the submerged pumps will be removed as new STP piping sumps are being installed .

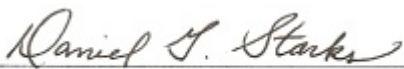
