Extra tanks was added to this permit and not needed because the ball floats were able to be tested and passed, see below note.

My office guy put down the wrong tanks for the permit, 1,2,3,5, when what I failed was 2,3,4,5. Tank #1 previously passed. During re-inspection, I was able to remove and test the ball floats on tank #4, and #5, so my permit was only needed for #2, and #3.

During annual inspection, the triennial inspection of the ball float vents failed because they could not be removed for this inspection. they will be replaced with drop tube/valves on these tanks.
