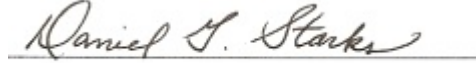

- (5) **SPECIAL CONTINGENCIES** : Replace spill containers and drop tubes on 3 tanks. Remove ball only from ball floats on all tanks.
