Permit for REMOVAL of Underground Storage Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(4) After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

(5) **SPECIAL CONTINGENCIES** : REM permit issued after the fact. Removal of damaged piping and installation of new piping both in a chase, reported to OSFM on an Emergency Repair Request. Request was denied due to scope of work exceeding an Emergency Repair and a removal being involved. REM and UPG permit applications submitted today. Inspector Weedman informed. Office staff putting the piping only removal on his schedule for today so a Log of Removal can be completed. Contractor informed that the procedure followed was not correct.
