(5) <u>SPECIAL CONTINGENCIES</u>:

Tanks 15,16, & 18 had valves (OPW 61SOP) installed by others without a permit. We will be inspecting the valves for functionality prior to final being submitted. Tank #13 100% Soy also had a valve installed by other without a permit. Tank #13 has a OPW 71SO and will also be inspected for functionality.

Ball floats for tanks 15,16 & 18 will be disabled or removed at time of project.

Note: There is a Veeder Root overfill alarm at the facility and the over fill alarm is connected to the DEF tank only.
