The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.


- (5) **SPECIAL CONTINGENCIES** : Disable ball floats and install drop tubes for overfill on all tanks. Replace spill container on tank 1.
