This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

Tanks #1 and 2 will not be removed at this time. Will apply for removal at a future date.

Removal of (1) 12,000 gallon UST's no longer needed. The (2) 1,000 gallon tanks will be removed at a later date.
