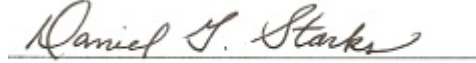
(5) **SPECIAL CONTINGENCIES** : Replace spill containers. Remove ball only from ball floats and install overfill alarm.
