Permission to upgrade or repair underground storage tank(s) or piping is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. **(5) SPECIAL CONTINGENCIES :**

Existing out of service / abandon CNG future island to be Reconstructed for regular unleaded service, installing one new Bravo single wall FRP under dispenser containment sump and new OPW flex works 1½" double wall piping in 4" access pipe from the island to the existing regular unleaded tank top sump. Changing Product Line Service : Evacuating the existing regular 2" LCX unleaded line and disconnecting it from the Regular STP / UST and reconnecting it to the E85 STP / UST. Then installing two new E85 dispensers on the existing islands / sumps that were previously regular

unleaded.


