Adding two STP sumps with interstitial monitoring to project scope and replacing the remainder of single wall pipe with double wall pipe

Bravo single wall sumps will be installed at tank top with non-descriminating sump sensors (Veeder Root). New Ameron LCX will be installed from tank sumps to dispenser sumps. This additional scope

will ensure the entire site will be double wall LCX pipe with sensors at all sumps.

NOTE: Contractor is now repiping the whole site
